Please find an introduction about our work and our approach on our website. If you, thereafter can image yourself working with us on projects we would be delighted to hear from you again.

All creative practitioners we link up with are creative individuals, organisations and therapists, who are interested in working on a self-employed basis with us. The scope of work will depend on the number of customers and their clients as well as the grants available. Intervention could take place through both one to one and group sessions depending on the activity. Work takes normally place on other organisations premises. Otherwise venues have to be negotiated and we are always interested in utilising studios around the county; due to the clientele we do not allow work with clients on private premises and home studios. If you have a studio or workspace you would like to hire out from time to time, please let us know. Before we incorporate on a project with you we will meet with you, you have to provide evidence of your qualification, approach and experience and produce a valid extended CRB check and insurance cover. Pay has to be negotiated. Send a costing sheet of yours with the application form at the bottom if possible. Generally we work according to the professions legal body (re. HPC) and the guidelines of the Art Council England.

### Who are we looking for?

Some of our clients are challenging and we often work restrictive setting or circumstance. This can be exhausting, stressful and emotional. On our more challenging projects a lot of clients can lack social skills, which make it hard to place them in a group. We give introductory training where appropriate, and on-going support for all our partners and provide professional supervision for them on long-term projects at a ratio of 20h contact time to 1.5 hours clinical supervision.

Issues involved are children and vulnerable adults protection and support policies, CRB checks, good practise codes, equal opportunity policies, data protection, health and safety implementation, confidentiality policy and the voluntary nature of attendance. You will be sent a brochure on our codes and policies when engaging in a project as a partner.

### Contracts

All work is on a freelance basis. No commitment taken until a contract with Creative Expression has been exchanged.

If you are registering as self employed practitioner interested in session work with our clients, Creative Expression will approach you in the case that a client is interested in/ suitable for your work/art form.

All other negotiations inclusive number of sessions, work hours, venue, number of clients, health and safety, pre contract determination, insurances and file access about the client have to be agreed before any work is undertaken on our behalf.
